TWENTY FOURTH (XXIV) CONVOCATION, 2026

NOTIFICATION FOR ONLINE APPLICATION

The XXIV Convocation of Dibrugarh University shall be held tentatively in **February, 2026**. In the Convocation, degrees shall be conferred on the eligible candidates who had qualified for *all the degrees of the University (having cleared their Final Semester Examinations) during the period from 01.11.2024 to 31.10.2025*. However, the candidates that have qualified /will qualify for the *Ph.D Degrees during the period from 04.03.2025 to 02.01.2026* are eligible to apply for the Convocation. The Certificates of Post Graduate and Ph.D. Degrees shall only be distributed during the Convocation. The Certificates of other Degrees shall be distributed on subsequent dates and venues, which shall be notified later on.

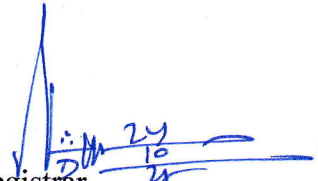
The Submission of Online Application of the XXIV Convocation of Dibrugarh University by the eligible intending candidates *shall begin from 01.11.2025. The last date for submission is 02.12.2025(till 11.59 P.M.), For the Ph.D. Degrees, the portal shall be open till 07.02.2026.*

HOW TO APPLY

1. For submission of the Online Application Form, intending candidates are advised to follow the below mentioned instructions:
 - a. The candidates shall have to register in the portal <https://convocation.dibru.work/> by entering Full Name, Email, Mobile Number and Password to login. The candidate will get “OTP” in the mobile and in the email for verification.

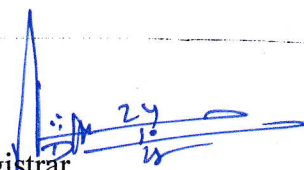
- b. After verification, the candidates shall have to log in with mobile number and password and has to fill up the Online Application with correct and appropriate information.
- c. The applicants shall have to pay prescribed fees through the online payment gateway by using Debit Card/Credit Card/ Internet Banking during the submission of form. No other mode of payment is acceptable. The prescribed fees to be paid by a Candidate is given as below-
- i. ***Certificate Fee-Rs.850/- (Only for the Candidates of Under Graduate Degrees and the PG and Ph.D Candidates who will NOT participate in the Convocation Ceremony).***
 - ii. ***Certificate & Convocation Fee -Rs.1,600/- (For the Candidates of PG and Ph.D. Degree who will participate in the Convocation Ceremony).***
 - iii. ***Only one person may accompany along with each Ph.D. candidate as a guest subject to the payment of additional fee of Rs. 500/-.***
2. The applicants can save and review the information entered before Submission, which can be edited on subsequent login. However, after Submission, editing of information shall not be possible.
3. On Submission of the Online Application Form by an applicant, a successful message will appear and the application form can be downloaded/printed with a Unique Application Number which may be saved or printed for future use. The applicants are advised to take a print of the Online Application Form for any future reference.
4. However, a successful submission shall not imply that the application of a candidate is considered as correct and valid. This shall be ascertained after further verification by the University.
5. There shall be no alternative procedure for Application for participation in the XXIV Convocation and the University shall not receive the Application Fee except the procedure mentioned at 1(c) above.
6. The subsequent notification related to XXIV Convocation shall be notified by the University from time to time.
